4. FIRST-AID MEASURES

First Aid Measures

Eye Contact	Rinse immediately with plenty of water, also under the eyelids, for at least 15 minutes. Remove contact lenses, if present and easy to do. Continue rinsing. If eye irritation persists: Get medical advice/attention.
Skin Contact	Remove/Take off immediately all contaminated clothing. Rinse skin with water/shower. Use Collodion Remover or acetone to remove Collodion residue. Wash contaminated clothing before reuse. If skin irritation persists, call a physician.
Inhalation	Remove victim to fresh air and keep at rest in a position comfortable for breathing. If symptoms persist, call a physician.
Ingestion	If conscious give 2 glasses of water to dilute. Do not induce vomiting. Never give anything by mouth to an unconscious person. Seek medical attention. Rinse mouth.

Most important symptoms and effects

Symptoms Direct contact with skin can cause irritation or redness. Mist or vapor inhalation can cause irritation to the nose, throat, and upper respiratory tract. May cause drowsiness or dizziness. Harmful if swallowed. May cause nausea, vomiting, stomach ache, and diarrhea.

5. FIRE-FIGHTING MEASURES

Suitable Extinguishing Media

Carbon dioxide (CO2). Dry chemical. Alcohol resistant foam. Use water spray to cool fire-exposed containers.

Unsuitable Extinguishing Media Do not use a solid water stream as it may scatter and spread fire.

Specific Hazards Arising from the Chemical

Highly flammable liquid and vapor. Closed containers may explode due to buildup of pressure when exposed to extreme heat. Vapors may travel to source of ignition and flash back. Vapors may cause flash fire.

Hazardous Combustion Products Products of combustion include compounds of carbon, hydrogen, and oxygen, including carbon monoxide. Acrid smoke and fumes emitted if heated to decomposition.
